4. Activities of the budgetary authority

4.1. The public-service implementation tasks of the budgetary authority:

The KRTK shall perform the public-service tasks specified in Act LXXVI of 2014 on Scientific Research, Development and Innovation as a central budgetary body, within the scope defined and detailed in the present Statutes.

- 4.3. The core activity of the budget body:
 - 4.3.1. The research centre, which consists of the Institute of Economics, the Institute for Regional Studies and the Institute of World Economics, carries out theoretical and empirical scientific research into Hungarian economics, the international economic and political environment and in the fringes of other social sciences. Its mission is the scientific analysis of the spatial economic and social processes of the market economy, in particular the Hungarian economy and its international economic and political environment. The Centre publishes and disseminates new research results, develops the scientific tools for research and develops the appropriate and necessary databases for the economic and regional research

; it formulates conclusions and recommendations for policy makers, develops and participates in master's and doctoral level university education programmes and curriculum development related to the disciplines covered by the Centre.

4.3.2. The KRTK and its institutes are particularly concerned with the following core research activities

related to the following disciplines and research tasks:

In the field of economics:

- the interaction of macro and micro factors of economic growth and their relationship with policies;
- -how the Hungarian labour market interacts with economic cycles and policies;
- modelling and measuring the functioning of public secondary and tertiary education and developing social policy proposals;
- market theory, business theory and their policy applications;
- integration, adaptation and competitiveness: opportunities to catch up in the post-crisis global environment;
- research on agricultural economics, biodiversity economics and rural development, and their policy applications;
- community economic research to explore the links between policies and mechanisms of action;
- cooperative game-theory models for examining strategic issues of economic competition and cooperation;
- a complex, multidisciplinary analysis of the design of matching markets and their practical applications;
- the development of urban benefits, the structural characteristics of connection networks and the interactions that can be captured by networks
- exploring the links between health status, health care utilisation and socioeconomic conditions, focusing on Hungary.

In the field of regional research:

- the international context of regional development, the cohesion and structural policies of the European Union;
- geopolitical and geoeconomic studies, including
 - frontier research,
 - o the territorial development of Eastern, Central and South-Eastern Europe,
 - o the regional transformation of the Carpathian Basin,
 - o research on other macro-regions of high geopolitical importance;
- -Spatial processes and territorial policy in Hungary;
- the characteristics of the spatial structure of the economy and society, and the factors and processes that influence them, spatial theory research: spatial processes;
- spatial types (region, county, district, dynamic and underdeveloped areas, urban and rural central and peripheral spaces) and connectivity;
- territorial governance and development institutions, regulation and territorial strategy-making, analysis of the territorial impact of territorial policy and other public policies;

-studying the interaction of (socio-economic) territorial processes with the environment and climate change.

In the field of world economic research:

- -the changing conditions for the international competitiveness of the Hungarian economy in the global economy of the 21st century;
- -the medium-term evolution of the world economy, in particular the transformation of the structure of production, finance and consumption;
- -the shifting balance of power between the main traditional and new players in the world economy (mainly China, India, Russia, Brazil and other emerging economies) and the new opportunities and risks involved for the Hungarian economy;
- -theoretical and economic policy analysis of global crisis management;
- the challenges posed by the European Union and the economic and economic policy conditions for a successful Hungarian EU membership;
- the role of the global multilateral cooperation network in the natural and social sustainability of world economic development;
- -the main areas of economic security and Hungarian priorities (energy, raw materials, food, technology, environment);
- -the micro-sphere of the world economy: traditional and new elements of the multinational corporate system in the post-crisis world economy, taking into account (changing) Hungarian interests.

4.3.3. Other tasks related to the research tasks of the KRTK:

- to publish scientific, professional and educational publications in the context of its activities;
- −to support the cultivation of science in Hungarian and foreign languages;
- −to facilitate the development of international scientific relations;
- -to cooperate with domestic research centres and research institutes, and conduct joint research with them; to maintain and establish relations with scientific institutions of other countries, international scientific societies; to promote the presence of Hungarian economic, world economic and regional research in the international life of the discipline;
- to organise national and international scientific programmes and conferences;
- to promote and facilitate the social and economic utilisation of the results of scientific research;
- -to participate in teaching, research, training and further education activities in cooperation with higher education institutions in Hungary and abroad;
- to operate specialised libraries,
- to keep records of the properties it uses and undertake the tasks related to their operation and maintenance;
- to operate and maintain research infrastructure, research tools and materials and to obtain those tools and materials.

5. Organisation and operation of the budgetary authority

5.1. Election and assignment of the head of the budgetary authority:

The KRTK is under the management of a single person, and its activities are directed by the Director General as a senior employee under Act I of 2012 on the Labour Code.

The Director General is elected by the Governing Board of the Eötvös Loránd Research Network Secretariat for a maximum term of five years, on the basis of a competitive application, and the President of the Eötvös Loránd Research Network Secretariat exercises the powers of the employer.
